- 2) Deposit of (\$200.00 for Main hall) (\$100.00 for Mini Hall) must be made upon signing agreement. Deposit is refundable if:
  - (a) Event is cancelled more than 60 days prior to scheduled event OR
  - (b) If less than 60 days prior to scheduled date of event; and another event is scheduled in its place.
  - (c) The deposit will be applied towards rental price at time of full payment.
- 3) Renter will be held financially responsible for any physical damages caused during event.

Shawnee Volunteer Fire Company, Inc. reserves the right to require Renter to provide a major credit card upon signing agreement, which shall be charged for reimbursement of any and all such damages due to negligent or intentional acts or omissions during event caused by Renter or guests. The Renter specifically agrees that Shawnee Volunteer Fire Co., Inc. may charge the card for costs incurred as a result of any such damages and further that Renter shall also be responsible for any such costs that exceed what was able to be collected on the credit card.

4) Maximum 6-hour length. Extension of time will be reviewed with rental coordinator and may result in additional fees depending on services requested.

5) Bar will be open for 5 hours, unless otherwise agreed upon at a rate of \$50/hour

6) Bartenders shall have the right to refuse service to anyone for any reason, and to verify ID and age of all persons seeking service of alcoholic beverages.

7) Areas of hall not specifically rented are off limits.

8) The entire building is a no-smoking facility.

9) Guests may not park in front of fire truck doors or parking lot in front of truck doors.

10) The use of kitchen is prohibited except for a licensed and insured caterer; Shawnee Volunteer Fire Company, Inc. reserves the right to verify licensing and proof of insurance coverage prior to its approval of all caterers.

11) Subject to the limitations of paragraph (12) below, no outside food or beverages may be brought into facility.

12) A maximum of one bottle may be brought in to be controlled by bartender(s) for one specific person, with the prior written approval of the Shawnee Volunteer Fire Company, Inc.

13) No shots of alcoholic beverages shall be poured or served by bartender(s).

14) No pitchers of beer or pop will be provided unless agreed upon with rental coordinator

15) Nothing to be attached to walls by any manner.

16) No standing on tables or chairs within the Hall.

17) Caterer's fee shall be separately negotiated, contracted, and paid by Renter, and is not included in payment for hall.

18) Final payment of Hall rental shall be due and payable prior to setup for event unless specific prior arrangements are made by and agreed to by both parties in writing.
